## OFFICIAL PARISH COUNCIL SURVEY

### Village Centre Covid-19 Social Distancing Measures

Dear Sir/Madam,

The Parish Council would welcome your feedback on a trial pedestrianisation scheme for part of the village High Street. The purpose of this temporary measure is to assist in the safe re-opening of the village centre by maintaining social distancing during the Covid-19 pandemic. The measures are being developed by Gloucestershire County Council and Cotswold District Council in liaison with the Parish Council.

The proposed area (see attached map) would be from the Post Office corner to Hartwells ironmongers in the High Street. No traffic would be allowed from the High Street over the Kingsbridge during the restricted times therefore local traffic would be sent over the Sherborne bridge. Moore Road would remain two way with traffic. Lansdowne is proposed for Local Bus access only from the Fosse Way. Local traffic within Lansdowne will be able to travel both ways and up Moore Road. All other traffic from the A429 would be directed up the Fosse Way and to turn right at the lights into Station Road.

The measures put in place will be monitored in respect of their effectiveness in achieving social distancing and in respect of their impact on the economy and general "health" of the village centre. Results of the monitoring will be taken into account when the monitoring period ends. Please be aware that the measures may remain in place either as is, or in a modified form until the Covid-19 threat has receded.
